GENERAL INFORMATION

1. Background and Intent

- A. Maryville Housing Development Corporation (MHA)is a high-performing public housing agency serving Blount County. It manages 400 public housing units, 356 housing choice vouchers, 118 one-bedroom high rise multifamily apartments, and six privately owned properties. The agency was the first housing authority to receive a Moving to Work Designation in Tennessee.
- B. Definition/Clarification: MHA uses "suppliers" as inclusive of various words describing interested parties often called "bidders", Suppliers", "contractors", "proposers" and "vendors".
- C. While MHA has its own employees who perform HVAC work, from time to time, MHA needs supplemental HVAC services from suppliers. Suppliers holding MHA's award for HVAC services meet these needs. Such needs arise when MHA employees do not have the capacity or when special skill sets are needed.
- D. The Supplier(s) may perform tasks such as (this is not an all-inclusive list):
 - Adjusting HVAC units
 - Installation of new HVAC units
 - Installation of PTACS or Mini-Split units
 - Repair to existing units
- E. See the Scope of Work sections for the technical details
- F. MHA reserves the right to award up to five (5) suppliers to meet its varied needs. IF MHA awards to multiple suppliers, when a job is expected to reach \$3,000 in value, MHA staff will contact all awarded suppliers for a specific quote for the work (based on award cost terms). MHA reserves the right to move forward with any one supplier if its best interests are served.
- G. If MHA awards to multiple suppliers, if costs, supplier expertise, work quality and completion timelines are equal, MHA staff will try to alternate work between awarded suppliers.
- H. Typically, MHA will not use this solicitation for projects if the costs exceed \$25,000. However, MHA reserves the right to do so if its in MHA's best interest.

I. Any agreement resulting from this solicitation will be an "open-end" type of agreement. There is no guarantee that MHA will require any specified or minimum level of services or provided by the supplier.

2. Changes After Award

It is possible that after award, MHA will need to revise requirements specified herein. MHA reserves the right to make such changes after consultation with the supplier. Should additional costs arise, the supplier must document increase costs. MHA reserves the right to accept or reject and negotiate these charges. Generally, such changes will not be of a "cardinal" nature.

3. Codes and Ordinances

All work covered is to be performed in fill accord with national, state and local codes, ordinances and orders that are in effect at the time the work is performed.

4. Contact Policy

ONLY contact the Housing Operations Manager about this solicitation until award. Information obtained from an unauthorized officer, agent, or employee will not affect the risks or obligations assumed but the supplier or relieve the supplier from fulfilling any of the conditions resulting award for the purpose of this project. Such contact can disqualify the supplier from the solicitation process.

5. Damage

The supplier is responsible for all damage to building, equipment, grounds, premises and all other types of potential damage resulting from the provision of the services requested herein.

6. Employees:

Supplier will:

- A. Provide at least one employee on every job assignment with the ability to speak, read, write and understand English so owner's staff can communicate effectively with them.
- B. Ensure that employees have proper identification displayed while on site, they must wear a company uniform or have photo identification displayed.
- C. Employees parking vehicles (whether corporately or privately owned) must ensure that the company identification is on the vehicles. His may be placards on the vehicle's side, laminated paper with the company name placed on the dashboard or other means.

7. Entrance to Sites

Suppliers' employees are not to be on MHA premises unless they are working on an MHA project. Acquaintances, family members, assistants to any person not working on MHA's behalf will not accompany employees on MHA sites.

8. Equipment

Supplier shall provide all necessary equipment, materials, et cetera needed for the work. Include the cost for such equipment, materials and supplies in the price quoted.

9. Evaluation

- A. MHA alone determines the suppliers "responsive" and "responsible" status prior to award. Responsible means a business with the financial and technical capacity to perform the requirements of the solicitation and subsequent contract. A responsive proposal is one that fully conforms in all material respects to the solicitation document and all of its requirements, including all form and substance.
- B. MHA reserves the right to request additional information to assist in the evaluation process. This includes references and business capacity information.
- C. MHA will review proposals and reserves the right to request necessary modifications, waive minor technicalities, reject all proposals, reject any

- proposals that does not meet the mandatory requirement(s) or cancel this RFP, according to MHA's best interests.
- D. MHA's Evaluation team may elect to interview one or more suppliers before making an award.
- E. MHA's Evaluation team may elect to first rank proposals with a simple numeric score and then detail score only the top tier of proposals.
- F. MHA score and award to the best overall proposer(s) on the following evaluation scale:

10. Insurance

See Appendix 1. These insurances and levels are required and not optional. If you or your insurance agent have concerns or believe that some coverages are not necessary, email cblair@mhatn.com detailing any requested changes before this solicitation's due date. The supplier will include all insurance costs in the base bid.

 Upon notice of intent to award, your insurance agent will email questions and the proposed Certificate of Insurance (COI) to <u>cblair@mhatn.com</u> for review.

11. Invoicing/Ordering

- A. Until a purchase order is in place, work is not to be performed nor are goods to be delivered. MHA does not have legal obligation to pay for work performed prior to the issuance of a purchase order.
- B. Suppliers must submit invoices within 60 days of delivery of goods or services. MHA may deny invoices submitted after the 60-day threshold.

- C. MHA's purchases of goods are exempt from Tennessee sales and use tax pursuant to Tennessee Code Annotated 67-6-329(a) (4) and MHA is generally exempt from the Federal Excise tax. However, suppliers are subject to Tennessee sale and use tax on all materials and supplies used in the performance of a contract, whether such materials and supplies are purchased by the supplier, produced by the supplier, or provided to the supplier by MHA, pursuant to Tennessee Code Annotated 67-6-209.
- D. The supplier pays all taxes incurred in the performance if an awarded contract. Upon placement of a purchase order or the award of a contract, MHA will provide a State of Tennessee Sales Tax Exemption form to the supplier. MHA will not pay taxes on invoices.
- E. MHA pays by electronic transfer (ACH) or by check.
- F. MHA requires that once a purchase order is established, invoices must be emailed to our accounts payable staff at ap@mhatn.com
- G. Invoices Must:
 - Be numbered
 - Show a date that is after the work is complete or goods delivered
 - List the location where services are being performed
 - Breakdown pricing according to the award structure

12. Length of Award

The length of the contract will be twelve months with four optional annual renews that MHA may exercise at its discretion.

13. Licensure

- A. Suppliers must be properly licensed by the State of Tennessee and all other authorities having authority. Throughout the term of this contract, the supplier shall keep the required license.
- B. In addition to any City or County licenses that may be required, all suppliers must be licensed contracts as required by the "Contractor's Licensing Act of 1994" as mandated by the State of Tennessee. The supplier must have the necessary licensing classification as required by the Rules of the Tennessee Board for Licensing General Contractors. Certified Mechanical

HVAC/Refrigeration Contractor (CMC-C), Certified Mechanical Contractor (CMC)].

- C. EPA Section 608 Technician Certification
- D. Throughout the term of this award, the supplier shall maintain the required licenses.

14. Material and Workmanship

All materials and equipment furnished shall be new and of high quality. Work shall be accurate, skilled, and subject to MHA's approval. All materials and equipment provided shall conform to regulations of enforcement bodies having authority.

15. Measurements and Drawings

The supplier shall verify all dimensions with the actual on-site conditions.

16. Permits

The supplier (and/or subcontractors) shall obtain and pay for all permits required to complete authorized work. Costs for permits should be worked into base bids.

17. Price Structure

- A. At the end of each twelve-month period, the awarded supplier may request a change to the percentage and/or specific item changed to MHA. The supplier must provide proof of the necessity of the increase to the Housing Operations Manager. Such proof will be CPI, PPI or other similar documentation acceptable to MHA. MHA will decide whether to accept a price increase. If MHA accepts the price increase, the bid file will note. If MHA rejects the price increase, the supplier may:
 - 1. Continue with the existing price.
 - 2. Suggest and alternative price increase.
 - 3. End the award.
- B. MHA does not pay fuel surcharges.
- C. Suppliers may decrease prices at any time with or without notice.

18. Renovation, Repair and Painting Rule.

- A. Suppliers performing renovation, repair and painting projects that disturb lead-base paint in home, childcare facilities, and schools built before 1978 must be certified and must follow specific work practices to prevent lead contamination. When work is occurring at a site, the supplier must submit proof of the applicable certification before beginning work. The supplier will keep such certification current throughout the life of the award.
- B. Not all MHA sites are subject to RRP rules since some of MHA's sites were built after 1978, some sites have been remediated, and some sites are exempt.

19. Representations

By submitting a response, the supplier certifies:

- A. That the supplier is financially solvent and that it is experienced in and competent to perform the type of work, and/or to furnish personnel, plans, materials, supplies, or equipment to be performed or furnished by it; and
- B. That the supplier is familiar with all federal, state, municipal and county laws, ordinances and regulations, which may in any way affect the work of those employed therein, including but not limited to any special acts relating to the work or to the project of which it is a part; and
- C. That the supplier carefully examined the plans, specifications and the worksite and that from its own investigations, has satisfied itself as to the nature and location of the work, the character, quality, quantity of surface and subsurface materials likely to be encountered and character if equipment and other facilities needed for the performance of the work, the general and local conditions and all other materials which may in any way affect the work or its performance.

20. Safety/OSHA Guideline Compliance

- A. The safety of the public is of prime concern to MHA, and all costs associated are the responsibility of the supplier. The supplier shall ensure that its employees exercise all necessary caution and discretion to avoid injury to persons or damage to property.
- B. The supplier will provide and place barricades, tarps, plastic, flag tape and other safety/traffic control equipment to protect the public, surrounding areas, equipment and vehicles as appropriate. This includes taking the necessary steps to exclude persons (residents, visitors, other contractors) from entering work areas.
- C. The supplier shall ensure that the flow of vehicular traffic is impeded as little as possible during projects.
- D. The supplier will protect all buildings, appurtenances and furniture from damage. The supplier shall. At their expense, repair such damages (or replace items) by approved methods to restore the damaged areas to their original conditions.
- E. Supplier shall use caution signs as required by OSHA Regulation 29 CFR 1910.144 and 1910.145 at no cost to MHA. Caution signs shall be on site on commencement of work.
- F. Supplier shall comply will all other OSHA and TOSHA safety standards that apply.

21. Section 3 of the HUD act of 1968 (as amended)

All contracts awarded are subject to section 3 requirements. Supplier shall seek to fill any and all position(s) that are needed and unfilled with residents of MHA communities. For additional information, go to https://www.hudexchange.info/programs/section-3/ Upon award, the successful suppler will supply MHA with job announcements for any positions that must be filled as a result of the award of MHA work.

22. Security

Supplier is responsible for providing all security for equipment, materials, personnel and tools required for this work. MHA is not responsible for damage or losses to equipment, materials, personnel or tools.

23. Smoke Free Policy

- A. MHA's Smoke Free Policy is applicable to you, your employees and subcontractors.
- B. Applicable definitions include:
 - "Smoking: meaning inhaling, exhaling, burning or carrying any lighted or heated cigar, cigarette, pipe, or any other lighted or heated tobacco or plant product intended for inhalation, including hookahs and marijuana, whether natural or synthetic, in any manner or in any form
 - "Smoking" also includes the use of an electronic smoking device which creates an aerosol or vapor, in any manner or in any form.
 - "Electronic Smoking Device" mean any product containing or delivering nicotine or any other substance intended for human consumption that can be used by a person in any manner for the purpose of inhaling vapor or aerosol from the product. The term includes any such device, whether manufactured, distributed, marketed or sold as an e-cigarette, e-cigar, e-pipe, e-hookah, or vape pen or under any other product name or descriptor.
- C. Should the supplier's staff be observed violating these requirements, MHA will notify the supplier about the problem. Repeated offenses may result in forfeiture of your awarded contract.

24. Subcontractors

Subcontractors must:

- A. Be approved by MHA prior to beginning work.
- B. Carry insurance coverages as outlined herein.
- C. Not be on the general federal government, HUD's nor the State of Tennessee's debarment lists.
- D. Not be changed without owner's permission.

25. Work Hours

Acceptable work hours are during our operational time of Monday-Thursday from 7:00am to 5:30 pm. Work on Friday-Sunday or Holidays requires MHA's advance approval.

DESCRIPTION OF WORK

26. Introduction

The supplier shall perform installation, maintenance and repairs on a Time and Material Basis for MHA equipment to:

- Maintain equipment in proper operating condition
- Install new equipment
- Repair existing equipment
- Perform all tasks associated with HVAC repair
- A. The supplier shall do all work necessary for the performance and completion of this work, in the manner called for, at the appropriate prices shown herein.
- B. The supplier shall provide all supervision, labor, service trucks, materials, tools, equipment, and appurtenances necessary for the completion of this work in the manner specified in this solicitation and the successful supplier's response to it.

27. After Hours Work

The supplier may be required to perform work during MHA's non-working hours or on weekends or holidays. The requestor or designated representative must approve all repairs including after-hours work. The supplier shall invoice at the rate of time and a half based on the regular hourly labor rates.

28. Call Back Service

Upon emailed or otherwise written notice from MHA, the supplier must without additional charge, replace/repair improper work or products installed within one year of service. Such callback services shall be within two hours of notification for emergencies and within twenty-four hours for non-emergency situations.

Should MHA and a supplier disagree about whether a call back service is a warranty issue, the supplier will submit details of the situation to MHA for reviewal.

29. Charges

A. Equipment Cost

Supplier shall charge their quoted rate per hour for actual time used only. The time that equipment sits idle is not billable. If a staff member has dual responsibilities as an equipment operator and as a plumber, his or her time will be separated appropriately as to the actual duties performed.

B. Labor

- 1. Supplier shall include all costs (overhead, profit, insurance, workmen's compensation, unemployment insurance, social security, et cetera), in the hourly rate figures. The only exceptions from this section are the cost of supplies and parts that are directly attributed to a specific job and the approved equipment rental.
- 2. Regular time will be MHA's normal business hours of 7:00 a.m. to 5:30 p.m., Monday through Thursday, unless otherwise authorized.
- 3. A maximum of one hour (thirty minutes each way) per day will be allowed for travel time (workman's hourly rate) between your business address (shop) and the job site. However, travel time closer to thirty minutes (fifteen minutes each way) shall be billed accordingly.
- 4. Supplier may be required to have hours work certified at the jobsite by MHA staff.
- 5. Additional vehicle mileage charges are not allowed
- 6. Supplier will deduct time consumed for meals eaten during the time on the job.

C. Materials

Supplier shall itemize materials or parts on the invoice (only those charges that are for equipment for that specific job) and add their markup (the figure shown on your bid submittal). MHA reserves the right to require documentation of the cost vendors pay for materials or parts.

D. Mobilization

1. Mobilization (if require) will be paid once for assignment regardless of scope of work.

- 2. Work in one area or on a street in which the areas of activity are contiguous or close together, regardless of the scope or scopes of work, is considered on job and the supplier shall be paid for one mobilization.
- 3. Work, at least one mile from the last work area that requires the suppliers' crew to break down equipment, relocate, and reset at the new work is a new job and the supplier shall be paid for another mobilization.
- 4. The pricing page for this solicitation provides a space for supplier to submit two mobilization charges. The supplier also inserts the dollar range for each price.

30. Demolition and Debris Removal

The supplier shall remove all debris from the site and clean affected work areas. Supplier. Supplier shall keep the premises free of debris and unusable materials from their work and work progresses; or upon requested by MHA shall remove such debris and materials from MHA property. The supplier shall leave all affected areas as they were prior to beginning work.

31. Equipment

The supplier is responsible for having or acquiring all standard equipment necessary to perform under this agreement. MHA shall not reimburse for any standard equipment or rental nor for damages incurred in using equipment for MHA's needs.

32. Estimates

- A. The supplier may be required to visit potential job sites and submit accurate quotations (based on award rates) before the work is authorized.
- B. If the quotation is accepted and the work is performed, the supplier's invoice shall not exceed the approved rates.
- C. The supplier must provide quotations within five business days of request.

- D. A list of proposed subcontractors (if any) will accompany quotes.
- E. As referenced above, "Quotes" mean a not to exceed cost for each job. Unless MHA authorizes additional work or approves changes for unforeseen conditions, the estimate (based on the awarded rates) will not be exceeded.

33. Hazardous Materials and Chemicals

- A. The supplier shall not use any materials or chemicals, which may be a physical or health hazard, without receiving prior written approval from the Project Manager. Along with the written request for approval, the supplier shall submit the manufacturer's specifications, a Safety Data Sheet, and any required Environmental Protection Agency (EPA) information on usage and handling.
- B. The definition of hazardous substances/materials includes such physical hazards as compressed gases, flammable liquids and solids, combustibles, and chemical oxidizers; and health hazards such as carcinogens, irritants, corrosives, sensitizers, and agents that may damage the lung, skin, eyes, or mucus membranes.

34. Inspection and Acceptance

MHA staff will inspect all work before acceptance. Once work is completed and officially accepted, invoices will be authorized for payment.

35. Materials and Workmanship

- A. All work must conform to the 2018 International Mechanical Code (IMC). Additional requirements may be directed to the vendor on an individual per job basis.
- B. All materials and equipment furnished shall be new and best quality.
- C. All materials and equipment provided shall conform to the regulations of the entities having authority.
- D. Supplier shall furnish material samples for approval if desired by MHA. MHA reserves the right to specify the materials to be utilized on specific jobs. MHA must approve substitutions.

- E. Work shall be accurate, professionally finished and subject to MHA's approval prior to payment authorization.
- F. The successful supplier(s) may be required to establish a mockup unit for larger projects. Once completed, MHA will examine mockup unit. Once approved, work may then begin in other units.

36. Project Service Tickets

- A. The supplier shall leave (or email) Services Tickets for all work performed. Each project requires individual service tickets that shall detail labor, materials utilized, rental equipment, and subcontractors utilized. The service tickets are submitted to the project manager or designee at the completion of the workday.
- B. Service tickets must include the following:
 - 1. Facility name
 - 2. Equipment name and id number
 - 3. Personnel name, labor classification, and hours worked
 - 4. Materials used
 - 5. A detailed description of work performed.

37. Property Damage

Should the supplier cause any damage to MHA property, the supplier must notify the project manager or his designee immediately and make repairs to the satisfaction of MHA, at no cost to MHA. However, MHA may elect to make repairs or replacement of damaged property and deduct the cost of such repairs from current or future pay applications.

38. Roof Protection

On those occasions where the supplier must do work on a flat roof, the supplier shall place protective plywood sheets of an appropriate size on the surface of the roof from the point of access to the point where the work is to be performed. Under no circumstances is the supplier to walk or work on a flat roof without first protecting it.

39. Warranty

The Supplier expressly represents, warrants and agrees that all goods, equipment, machinery, materials, services, or work provided or performed on or off MHA, under this contract will:

- A. Conform in all respects to MHA specifications, drawing, requirements, or other descriptions.
- B. Be fit for the purpose or purposes of intended use.
- C. Conform to all applicable local, state, and federal laws and regulations.
- D. Be of good quality, merchantable, of good workmanship, of materials best suited for the intended purposes, and free from defects of any kind or nature whatsoever.
- E. If said equipment, material, service, or work is found to be defective in workmanship, materials, or design, fails or is found to be nonconforming with the terms and conditions of this contract within twelve months after the date of acceptance, it shall, at MHA's option, be repaired or replaced at the MHA location by the supplier at absolutely no cost to MHA.
- F. All items delivered or supplied hereunder shall be free and clear of all liens, encumbrances, claims, and security interest of whatever nature and substance. Upon request, the supplier shall supply MHA with documentation satisfactory to it, evidencing the absence of such liens, encumbrances, claims, and security interests.
- G. The warranty period shall begin upon final acceptance of the work
- H. Warranties must indicate:
- The site that the work occurred at
- The area (apartment, floor, wing, et cetera)
- A description of the work performed
- The date the warranty commences

- 4. Supplier fully understands the preparation and contents of the attached offer and of all pertinent circumstances respecting such offer

6. Concerning the Iran Divestment Act (TCA 12-12-101 et seq.), by submission of this bid/quote/proposal, each supplier and each person signing on behalf of any supplier certifies, and in the case of a joint bid/quote/proposal, each party thereto certifies as to its own organization, under penalty of perjury, that to the best of its knowledge and belief that each supplier is not on the list created pursuant to § 12-106.

- 7.
